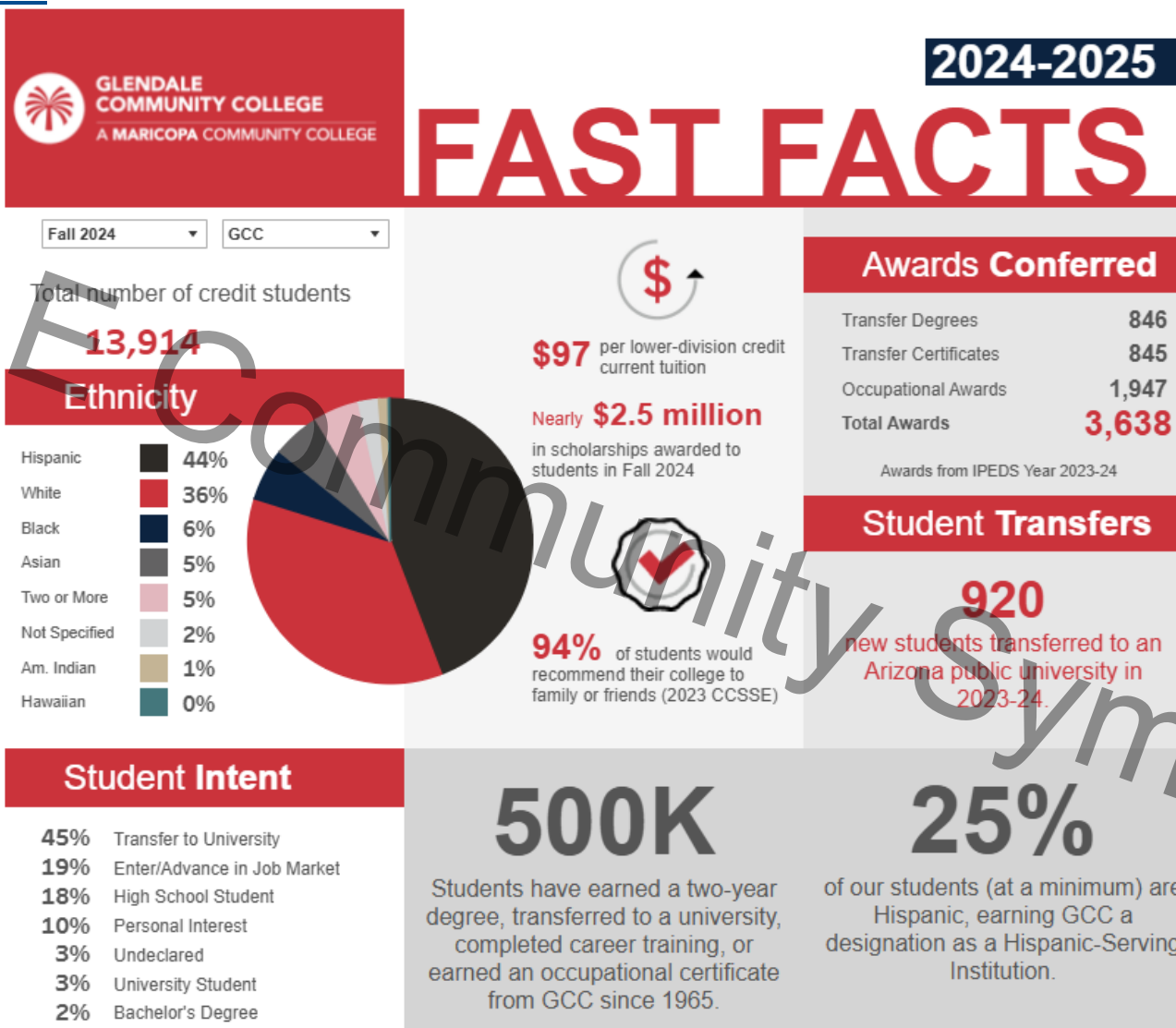

 - 9,914 Arizona

- Students could not find jobs in the field
 - Needed experience
 - Need an internship or job to get experience

2025 CAE Community Symposium

Solution:

***Brought the
internships to
the students***

- Built a Security Operations Center on Campus
 - STEM Grant (\$1,000,000)
- Partner with rural municipalities
 - Critical infrastructures that are at or below the cybersecurity poverty line
 - Offer security as a service
- Hire students as interns at the end of their program
 - Monitor – Detect – Inform
 - 300+ hours in a live SOC
 - Hands on analyst and engineer tasks
 - Teambuilding
 - Collaboration
 - Communication – written and oral

- Consistency through the RSOC for our interns and future cybersecurity employees

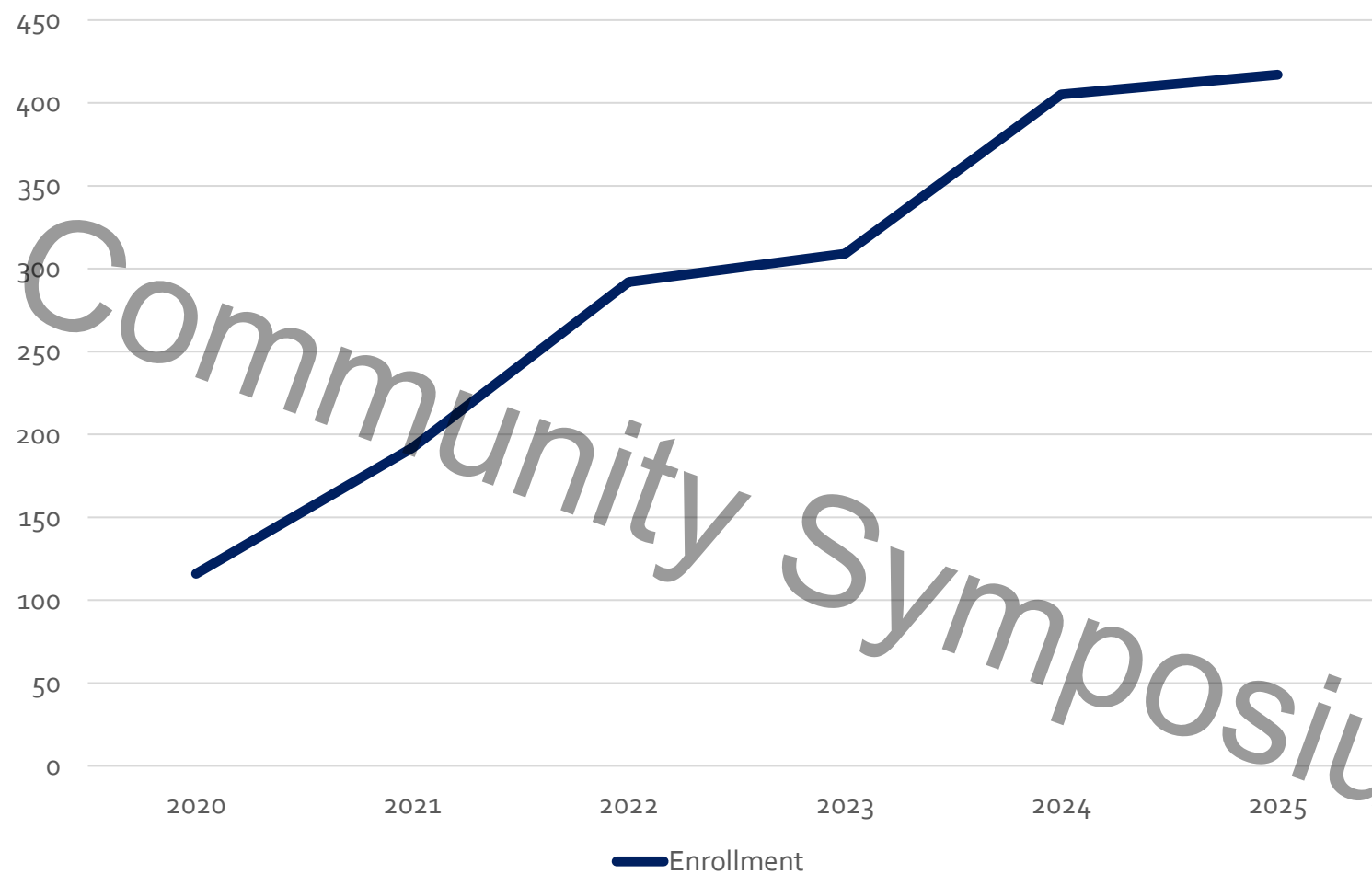
